Subject: Upgradation in respect of the above said school.

Dear Sir/Madam,

With reference to your application dated 28.06.2006 and subsequent inspection of the school, I am directed to convey the sanction for provisional affiliation to the above said school for **Senior School Certificate Examination** of the Board for a period of 03 years w.e.f. 01.04.2007 to 31.03.2010 in the following subjects:-

Hindi (Elective), English (Core), Economics, Mathematics, Physics, Chemistry, Biology, Business Studies, Accountancy, Computer Science

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

1. The school will provide additional suitable facilities for classes X and XII, as per requirements laid down in the rules.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
4. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
6. It will remit Annual Fee Rs. 4500/- @ Rs. 1500 per annum for three years (01.04.2007 to 31.03.2010) be also remitted at an early date.
7. The school should apply for further Extension of Provisional Affiliation before 30th June of the preceding year before the expiry of the date of Affiliation 'On Line' through CBSE Website www.cbseaff.nic.in or www.cbse.nic.in and send a copy of its confirmation page with prescribed fee of Rs. 12,500/- in the shape of Bank Draft drawn in favour of Secretary, CBSE, Delhi.


8. The school will be eligible to open CBSE pattern class XI w.e.f. 01.04.2007 only. Accordingly 1st Batch of class XII of the school will be appearing at the CBSE Examination to be held in the year 2009.
9. Other conditions are as per Annexure 'A' enclosed.

Conditions for immediate compliance:

1. Qualified teachers are required to be appointed in place of untrained teachers as per norms of the Board.
2. DA should be paid to the staff at least at par with the State Government Rules.

Compliance of the above conditions should reach to this office within **30 days** from date of issue of this letter.
